We have had the asbestos report back - I've attached it here. The main finding for you is that the old roofing felt over the main hall has asbestos in it - presumably this is the original felt from 1970's when it was built. Can you still remove this as part of your package, or do we need to get it removed by specialists? We are getting some prices for this as we speak, so let me know asap.
